## Array Animal Rescue Emergency Foster Contract

- In Signing this contract, I certify that I am at least 18 years of age and legally able to sign documents/contracts.
- I certify I am the legal owner of the animal(s) present here, or a representative acting upon the consent of the owner,
- I understand that the amount of time I am requiring AAR's services must be stated at or by the time of pick up and must be adhered to.
- I understand that if I am unable to pick up my pet(s) by the date stated, I must request an extension at least 3 days prior to the original date. This request will be reviewed and may or may not be approved.
- My pet(s) will be picked up by this date: (date of pickup)
- I understand that if an extension is requested, the maximum amount of time that can be granted is 90 days from the original drop off date.
- I understand that Array Animal Rescue's Emergency Foster program is up to a maximum of 90 days.
- I understand that if I request to pick up my pet(s) before the agreed upon date, that it will be at the convenience of the person fostering my pet(s).
- I understand if I misrepresent any statements in my application or this contract regarding my situation, or the behavior or health status of my pet(s), my pet(s) will be immediately exited from the program and I will be ineligible for future services.
- I understand my pet(s) will be boarded in a private foster home.
- I understand my information is confidential and will only be shared with necessary Array Animal Rescue parties, unless otherwise authorized.
- I understand that if my pet(s) are not reclaimed by my given check-out date, and the contract has not been extended, Array Animal Rescue possesses the right to place my pet(s) up for adoption or transfer my pet(s) to another rescue. At this point I will have no rights to my pet(s) and will not be compensated in any form.
- I understand that it is my responsibility to provide Array Animal Rescue with a working phone number/email that I can be reached at.
- I understand that I am required to check in with Array Animal Rescue at least every one to two weeks regarding my situation. At this time Array Animal Rescue will share photos/video or conference call with my pet(s).
- I understand that not checking in is breaking my contract agreement and is grounds to be tendered a 7 day notice (see below).
- I understand that Array Animal Rescue has the right to issue a 7 day notice for breach of contract in any manner. This notice will give me 7 days to reclaim my pet(s) before they are exited from the program.
- I understand that if I do not pick my pet(s) up by the end of 7 days of the notice, Array
  Animal Rescue possesses the right to place my pet(s) up for adoption or transfer to
  another rescue. At this point I will have no rights to my pet(s) and will not be
  compensated in any form.

- I understand Array Animal Rescue has the authority to make medical decisions for my pet(s) in case of emergency.
- I understand that Array Animal Rescue will spay/neuter (if not previously done) and fully vaccinate my pet(s) prior to returning them to me.
- I understand that all communication will go through an Array Animal Rescue leadership officer and/or my assigned case manager. There will be no direct contact with the person fostering my pet(s).
